In the Name of God a[????], I Mary Jane Fogan of NewCastle in the County of Northumberland widow being of sound mind and understanding make this my last Will and Testament.

1st I assign all my just debts and funeral expenses to be first paid out of my personal estate.

2nd I give devise and bequeath onto my beloved son William Fogan all my real and personal property of whatsoever nature and kind and wheresoever situate to him his heirs and assigns for him.

I hereby revoke all other wills made by me. I hereby appoint the said William Fogan sole executor of this my last Will and Testament. In witness whereof I have here[???]to set my hand and seal the sixth day of March in the year of our Lord one thousand nine hundred and [?]
